CONTRACT TO PARTICIPATE IN MOTORCYCLE SPORT EVENT

WARNING: This is an important document that affects your rights and obligations. Please read it carefully and do not sign unless you have understood and agree to its terms.

Motorcycle sport is an inherently dangerous activity which involves significant risk of loss or damage to property, personal injury, disability or death. Risk may vary due to the nature and type of terrain, weather conditions, the presence of animals or other elements in the environment, and in connection with other participants. **If you do not wish to be exposed to such risks then you should not participate in this motorcycle sport Event.**

The Organiser requires any person participating in the Event to indemnify and release the Organiser and the owners or occupiers of any land on which the Event is held from any liability for loss or damage to property, personal injury, disability or death arising from the Event.

If any parent or legal guardian of a **person under the age of 18 years on the day of the event** allows or encourages the younger person to participate in the Event, then that parent or legal guardian is hereby advised that the Organiser cannot accept any liability for loss or damage to property, personal injury, disability or death caused to the participant. The parent or legal guardian acknowledges that by signing this indemnity or by permitting the younger person to participate, the parent or legal guardian accepts complete responsibility for any loss or damage to property, personal injury, disability or death caused to the participant.

1. Acknowledgement of risks and dangers

I acknowledge that:

- a) I may be seriously injured, both physically or mentally, which may result in permanent disability or death.
- b) My motorcycle or any other equipment or personal property may be lost, damaged or destroyed.
- c) The course may be hazardous and conditions may vary without warning or the reasonable predictability of the Organiser.
- d) Other participants may ride dangerously or with lack of skill which may cause personal injury, disability or death of other riders as well as damage or destruction of property.
- e) By participating in this Event any policy of insurance with respect to my life or physical or mental health may be voided.
- f) There may be no or inadequate facilities for treatment or transport by ambulance to medical facilities if I am injured or killed.

2. Rider's Obligations and restraint

I acknowledge that:

- a) I am bound by the laws and regulations set out by Transport for NSW and NSW Police.
- b) I must use due skill and care at all times when riding on the course.
- c) I must follow the directional signage on the course.
- d) I must heed all instructions or directions given by the Organiser or its agents, officials or representatives.
- e) I must render assistance to other riders where necessary and notify the Organiser of persons requiring medical assistance or recovery without delay.
- f) I must not record, map or trace the course in whole or in part.
- g) Failure to observe my obligations may result in my removal from the course at the Organiser's sole discretion.

3. Indemnity and release

I agree that:

- a) I have read and understood the above information including all risks, dangers and obligations.
- b) All information provided on the entry form is true and correct.
- c) My participation in the Event is at my sole risk and responsibility.
- d) I accept the Venue as is on the day of the Event with all or any defects or hazards whether visible or hidden.



- e) I will not claim or institute legal proceedings against the Organiser or the owners and occupiers of the land on which the Event is held, their respective agents, officials and representatives, for any loss or damage to property, personal injury, disability or death I may suffer or cause other persons to suffer arising directly or indirectly from attending or participating in the Event.
- f) I indemnify, release and hold harmless the Organiser and the owners and occupiers of the land on which the Event is held, their respective agents, officials and representatives, against any claims or legal proceedings for any loss or damage to property, personal injury, disability or death I may suffer or cause other persons to suffer arising directly or indirectly from attending or participating in the Event.
- g) This indemnity may be pleaded by the Organiser or any owner or occupier of land used in the Event as a complete defence to any legal proceedings or any right I may claim against one or more of them.
